CADET & TRAINEE MEMBERSHIP CATEGORIES FACT SHEET

PLEASE NOTE

PARENTS AND GUARDIANS ARE WARNED THAT THE CLUB IS ONLY ABLE TO PROVIDE RESCUE FACILITIES DURING THE HOURS OF CLUB RACING OR TRAINING.

OUTSIDE THESE HOURS, PARENTS AND GUARDIANS HAVE SOLE RESPONSIBILITY FOR THEIR CHILDREN AND WARDS AND MUST APPRECIATE THAT THE CLUB CANNOT BE EXPECTED TO EXERCISE SUPERVISION OR CONTROL.

EVEN DURING CLUB RACING THE PERSON CANNOT ACCEPT RESPONSIBILITY FOR CHILDREN, OR ANY OTHER PERSONS, NOT ENGAGED IN RACING OR TRAINING.

TF - Trainee Family

Husband/Wife/Partner and any of their children who are under the age of 18 and whose requirements are of a purely social nature and who do not sail.

Carries **NO** voting rights.

This category to also include families who have one or more children between the ages of 7 and 14 who are signed up for a Training course. This will only apply as long as the child continues to attend the Sail training courses, otherwise the family will be deemed to be in the category of ' Full Family'.

When the child reaches 14 years they can join as a Cadet, in their own right to continue their sailing.

CT - Cadet

Any single person between the ages of 14 and 18 whose parents are not members of the Club and therefore cannot be covered under a Family Membership

Carries **NO** voting rights

Temporary

Any person who wishes to use the facilities of the club on a temporary basis for a period not exceeding three weeks

Includes boat park fee. £15.00 per week

BOAT PARK FEES

Multi-hull Boat £70.00 p.a.

Mono-hull Boat £50.00 p.a.

These boat park fees are subject to a maximum of £150 per family.

Associate members do not have access to a place in the Dinghy Park.

Cadets and Senior Citizens pay 50% of Parking Fees.

Trailers can only be accommodated in the Dinghy Park if under a boat.
